**MEMORANDUM OF LEASE**

**SCHEDULE NO. 2**

This is a Memorandum of Schedule No. 2 dated March 19, 2013 to a Lease Agreement made and entered into as of March 19, 2013 by and between Greenbrier Leasing Company LLC, an Oregon limited liability company, ("Lessor") and Prop Supply and Service, LLC, dba Rainbow Ceramics, a Texas limited liability company ("Lessee").

IN WITNESS WHEREOF, the parties hereto have caused this instrument to be signed by their respective officers as of the date and year first above written.






