TO LEASE AGREEMENT

Memorandum of Lease for Schedule No. 6 dated November 21, 2014 and effective as of December 1, 2010, to a Lease Agreement made and entered into as of January 1, 2008, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Lessor") and CSX Transportation, Inc., a Virginia corporation ("Lessee").




