**MEMORANDUM OF ASSIGNMENT OF EQUIPMENT LEASE AGREEMENT WITH
RESPECT TO LEASE SUPPLEMENT NO. 6
(Surface Transportation Board)**

THIS MEMORANDUM OF ASSIGNMENT OF EQUIPMENT LEASE AGREEMENT WITH RESPECT TO LEASE SUPPLEMENT NO. 6, dated as of May 30, 2014, is between BB&T EQUIPMENT FINANCE CORPORATION, a North Carolina corporation ("BB&T") and THE HUNTINGTON NATIONAL BANK, a national bank ("HNB").

The parties to this Memorandum hereby acknowledge and confirm the following:

A. THE CIT GROUP/EQUIPMENT FINANCING, INC., a Delaware corporation, has leased from BB&T certain railcars identified on Schedule 1 attached hereto (the "Railcars") under Lease Supplement No. 6 dated as of July 31, 2012 (the "Lease Supplement") to that certain Equipment Lease Agreement, dated as of July 31, 2012 (as amended, modified, supplemented and or replaced from time to time, the "Lease"). Three memoranda of Equipment Lease Agreement were filed with the Surface Transportation Board on July 31, 2012 under Recordation Numbers 25991-K, 21737-G, and 20972-UU relating to the Lease Supplement as well as other lease supplements under the Lease.

B. BB&T has sold the Railcars to HNB and assigned HNB all of its right, title and interest in and to the Lease, but solely with respect to the Lease Supplement and Railcars.

C. The parties hereto wish to show for public record this Memorandum and accordingly have caused this Memorandum to be executed by their officers thereunto duly authorized, as of the date first above written.

D. This Memorandum may be executed in counterparts, each such counterpart shall be binding on both parties hereto, notwithstanding that both parties are not signatories to the same counterpart.


