MEMORANDUM OF ASSIGNMENT

THIS MEMORANDUM OF ASSIGNMENT dated as of August 27, 2015 (the "**Memorandum**"), is between GREENBRIER LEASING COMPANY LLC, an Oregon limited liability company ("**Transferor**"), and EVERBANK COMMERCIAL FINANCE, INC., a Delaware corporation ("**Transferee**").

The parties to this Memorandum hereby acknowledge and confirm the following:

A.
