MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT

BETWEEN

GREENBRIER LEASING COMPANY LLC

AND

MUL RAILCARS LEASING, LLC

Memorandum of Assignment and Assumption Agreement (this "Memorandum") made and entered into as of June 29, 2015, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Assignor"), and MUL Railcars Leasing, LLC, a Delaware limited liability company ("Assignee").

WITNESSETH:


1. Assignor, as lessor, leased to Holcim (US) Inc., as lessee ("Lessee"), one hundred (100) 3,250 c.f., 286,000 lbs. GRL, covered hopper railcars, with three (3) 30-inch circular loading hatches and 13" x 42" discharge gates bearing Lessee controlled reporting marks and numbers GNAX 2700 through GNAX 2799, inclusive (the "Cars"), pursuant to that certain Lease Agreement made as of April 1, 2012 (the "Lease Agreement"), and that certain Schedule No. 2 dated as of August 1, 2014 (the "Schedule" and the Schedule incorporating by reference the terms and conditions of the Lease Agreement, the "Lease").
2. Assignor filed a Memorandum of Lease with the STB with respect to the Lease under recordation number 31774 on June 15, 2015 at 12:30 a.m.


