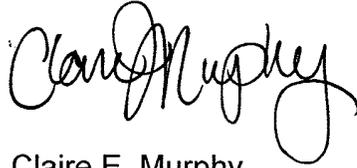

**MEMORANDUM OF  
BILL OF SALE AND  
ASSIGNMENT AND ASSUMPTION OF LEASE AGREEMENT**

This MEMORANDUM OF BILL OF SALE AND ASSIGNMENT AND ASSUMPTION OF LEASE AGREEMENT ("Memorandum") is made and entered into as of September 30, 2015, by and between FNBC LEASING CORPORATION ("Assignor"), and ALF P-I, INC. ("Assignee").

1. Assignor has agreed to assign to Assignee, and Assignee has agreed to assume, Assignor's rights and obligations under that certain Lease Agreement dated as of September 1, 1999 by and between Assignor and PCS SALES (USA), INC. ("Lessee") (the "Lease"), pursuant to which Assignor leased railcars to Lessee (the "Equipment"). In connection with such assignment of the Lease to Assignee, Assignor shall transfer all the Equipment currently subject to the Lease to Assignee pursuant to a Bill of Sale dated as of the date hereof.


