NOTICE OF FULL TERMINATION OF LEASE AND LEASE ASSIGNMENT

The undersigned, THE HUNTINGTON NATIONAL BANK (the "Lessor"), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, hereby gives notice that it has terminated the Memorandum of Lease, dated as of June 29, 2012, as amended, modified or supplemented (the "Lease"), with RAIL CONNECTION, INC., as Lessee (the "Lessee").

A Memorandum of Lease was duly filed and recorded with the Surface Transportation Board (the "Board") on July 11, 2012 under Recordation Number 29540-A. In addition thereto, a Memorandum of Assignment of Lease Agreement (the "Assignment"), from the Lessee, as Assignor, to the Lessor, as Assignee, was duly filed and recorded with the Surface Transportation Board (the "Board") on August 24, 2012 under Recordation Number 29540-C, in which the Assignor assigned its interest in a lease dated November 1, 2010 (the "Sublease") of sixteen (16) covered hopper railcars bearing JTSX reporting marks and numbers as more particularly set forth on Exhibit A attached hereto (the "Railroad Equipment"), from the Lessee to Canadian Pacific Railway Company. This document constitutes a release of all interests, claims, liens, or encumbrances by the Lessor over the Railroad Equipment and the Sublease.

This Notice of Full Termination of Lease and Lease Assignment is executed without prejudice to the rights or obligations of the parties which expressly survive under the Lease or the termination agreement between the Lessor and the Lessee and is intended to have no effect on the Sublease as between the parties thereto.
