**MEMORANDUM OF
ASSIGNMENT AND ASSUMPTION AGREEMENT**

This Memorandum of Assignment and Assumption Agreement ("Memorandum of Assignment Agreement") made and entered into as of February 11, 2016, by and between BANC OF AMERICA LEASING & CAPITAL, LLC, a limited liability company organized under the laws of the State of Delaware ("Assignor") and THE DAVID J. JOSEPH COMPANY, a Delaware Corporation ("Assignee").

WITNESSETH:

1. ASSIGNOR has agreed to assign to ASSIGNEE that certain Rider No. 1 to the Master Lease Agreement dated February 17, 2006 between ASSIGNOR (as successor-in-interest to LaSalle National Leasing Corporation), as Lessor, and ArcelorMittal USA, LLC (f/k/a Mittal Steel USA, Inc.), as Lessee (the "Lease"), for thirty one (31) railcars bearing the railroad reporting markings set forth on Schedule I. Such Lease was originally assigned by ASSIGNEE to ASSIGNOR pursuant to that certain Purchase and Sale Agreement dated February 23, 2006, by and between Assignee, as Seller and Assignor, as Buyer. Such assignment is evidenced by a Memorandum of Assignment and Assumption recorded with the Surface Transportation Board on March 24, 2006 under recordation No. 26244-F.


2. This Memorandum of Assignment Agreement shall be effective as of the date first set forth below.


