MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT

BETWEEN

GREENBRIER LEASING COMPANY LLC

AND

MUL RAILCARS LEASING, LLC

FEBRUARY 26, 2016

Memorandum of Assignment and Assumption Agreement (this "Memorandum") made and entered into as of February 26, 2016, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Assignor"), and MUL Railcars Leasing, LLC, a Delaware limited liability company ("Assignee").

WITNESSETH:



Assignor, as lessor, leased to Celanese Ltd., as lessee ("Lessee"), twenty-seven (27) 6,221 c.f. used covered hopper railcars equipped with 20-inch loading hatches, pneumatic discharge outlets and interior epoxy coating bearing reporting marks and numbers AOKX 62013, 62014 and 62020 through 62044, inclusive (the "Cars"), which have been leased pursuant to that certain Lease Agreement dated as of July 15, 2014 (the "Lease Agreement"), and that certain Schedule No. 1 entered into as of July 15, 2014, effective retroactive to August 23, 2013 (the "Schedule" and the Schedule incorporating by reference the terms and conditions of the Lease Agreement, the "Lease").
2. Assignor filed a Memorandum of Lease with the STB with respect to the Lease under recordation number 31428 on October 16, 2014 at 1:49 p.m.
3. Assignor has agreed to sell and assign to Assignee and Assignee has agreed to purchase and assume from Assignor, the Cars and certain interests under the Lease, and this Memorandum is being filed with the STB to reflect such assignment and assumption.
4. This Memorandum may be executed by the parties hereto in any number of counterparts, and all counterparts taken together shall be deemed to constitute one instrument.


