**PARTIAL TERMINATION AND RELEASE OF:  
MEMORANDUM OF LESSOR SECURITY AGREEMENT (US)**

September 28, 2015

The undersigned, SMBC LEASING AND FINANCE, INC. (the “Grantor”) and THE DOW CHEMICAL CORPORATION, a Delaware corporation (the “Secured Party”), are parties to that certain (i) Lessor Security Agreement, dated as of September 26, 2014, as supplemented by that certain Lessor Security Agreement Supplement No. 1, dated as of September 26, 2014 (as further amended, restated, supplemented or otherwise modified from time to time, the “Lessor Security Agreement”) and (ii) Memorandum of Lessor Security Agreement (US), dated as of September 26, 2014, as recorded with the Surface Transportation Board on September 26, 2014 under recordation number 31404-B (the “Memorandum of Lessor Security Agreement”), all with respect to the railcars identified on Schedule A hereto (the “Equipment”), in addition to other railcars.

The undersigned parties do hereby give notice of the termination of the Lessor Security Agreement with respect to the Equipment and all other forms of Collateral related to the Equipment only, as provided under the terms of a certain Partial Termination and Release Agreement, dated as of September 28, 2015 (the “Partial Termination and Release Agreement”). Capitalized terms used herein but not defined shall have the meanings given them in the Lessor Security Agreement.

Effective as of the date hereof, with respect to the Equipment and all other forms of Collateral related to the Equipment only, the Secured Party does hereby release and discharge the Grantor from each and all of its obligations and any claims and demands of every kind and nature, known and unknown, suspected and unsuspected, disclosed and undisclosed, related to the Equipment and all other forms of Collateral related to the Equipment and all other forms of Collateral related to the Equipment only arising out of or in connection with the Lessor Security Agreement and the Memorandum of Lessor Security Agreement; provided, however, that, as specified in the Partial Termination and Release Agreement, notwithstanding the termination and release contemplated hereunder, all provisions in the Lessor Security Agreement and the Memorandum of Lessor Security Agreement which by their express terms survive the expiration or termination of the Lessor Security Agreement and the Memorandum of Lessor Security Agreement, shall survive the termination and release contemplated hereunder.

Except as expressly set forth herein, no amendment, modification or supplementation is being made to the Lessor Security Agreement or the Memorandum of Lessor Security Agreement, and each of the Lessor Security Agreement, the Memorandum of Lessor Security Agreement and the other Operative Documents shall remain in full force and effect.






