RELEASE OF SECURITY INTEREST


The undersigned, acting on behalf of DVB BANK SE (formerly known as DVB BANK AG), as Secured Party (the "Secured Party") under the Loan and Security Agreement dated as of June 27, 2007, as amended (the "Loan and Security Agreement"), with Compass Rail IX Corporation (the "Borrower") for good and valuable consideration, the receipt and sufficiency of which are acknowledged, does hereby terminate, release and discharge any and all security interests held by it on (1) the 50' Plate C, 100 ton boxcars bearing marks CRLE 6200 through CRLE 6324, inclusive (the "Cars") and (2) the Equipment Lease dated as of December 13, 1991, between the Borrower as Lessor and Verso Corporation (formerly known as Verso Paper Corporation, as successor to International Paper Corporation as successor to Champion International Corporation), which were granted to it as Agent pursuant to the Loan and Security Agreement.

A Memorandum of Security Interest and Collateral Assignment of Lease relating to this Security Agreement was duly filed and recorded with the Surface Transportation Board on March 20, 2007 under Recordation Number 17629-E and, on the same date, with the office of the Registrar General of Canada under Document Key 18571. This document constitutes a release of all railroad equipment which is subject to the Lease and to the Lease, as amended, modified and supplemented as described in the Memorandum.
