**MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT**

This **AMENDED & RESTATED MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT** (“Assignment”) is made entered into as of February 29<sup>th</sup>, 2016 by and between The Andersons, Inc. (“Assignor”) and Siemens Financial Services, Inc. (“Assignee”).

**WHEREAS**, Assignor and Assignee previously entered into a Lease Assignment and Servicing Agreement dated effective as of February 9, 2015 which concerned a certain Full Service Lease Agreement Rider, Deal #R02363, dated effective as of July 11, 2014 between Assignor and Archer-Daniels-Midland Company (“Lessee”) evidence of which assignment was filed with the Surface Transportation Board under Recordation Number 31599-A on February 10, 2015.
