

**THIS NOTICE OF PARTIAL TERMINATION OF LEASE** is made as of this 5<sup>th</sup> day of November, 2014, by and between FIRST UNION RAIL CORPORATION, a North Carolina corporation (the "Lessor"), and NATIONAL RAILWAY EQUIPMENT CO., an Illinois corporation (the "Lessee").

WITNESSETH:

WHEREAS, Lessor and Lessee entered into that certain Equipment Lease Agreement and Lease Supplement No. 1 dated February 1, 2012, as amended (together, the "Lease"), evidenced by a Memorandum of Lease dated February 1, 2012 (the "Memorandum") which was recorded with the Surface Transportation Board on March 14, 2012 at 2:23 p.m. under Recordation No. 30123.


