MEMORANDUM OF ASSIGNMENT OF LEASE
(Schedule #1)

THIS MEMORANDUM OF ASSIGNMENT OF LEASE (this "Memorandum") dated as of this 30th day of October, 2015, is made by and between Midwest Railcar Corporation, an Illinois corporation ("Transferor"), and Redwood Rail, LLC, a Delaware limited liability company ("Transferee" and, together with Transferor, the "Parties").

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, TimberRail Services, LLC and West Range Reclamation, LLC, jointly and severally as lessee ("Lessee") are leasing the railcars identified on Schedule 1 attached hereto (the "Equipment") from Transferor, as successor lessor, pursuant to that certain Schedule #1 dated May 6, 2013 ("Schedule #1"), as amended, to that certain Full Service Master Lease Agreement effective May 6, 2013, each between Wells Fargo Equipment Finance, Inc. d/b/a Midwest Railcar Capital Equipment Company, as lessor (to which Transferor is successor lessor), and Lessee, as lessee (collectively, the "Lease").

WHEREAS, pursuant to a Purchase and Sale Agreement dated as of October 30, 2015 between Transferor and Transferee (the "Purchase Agreement"), Transferor agreed to sell the Equipment to Transferee and to assign to Transferee the rights and obligations of Transferor in, to and under the Lease arising after the dates of such sale and assignment under the Purchase Agreement, and Transferee agreed to purchase the Equipment and agreed to such assignment under the Purchase Agreement.

WHEREAS, Transferor and Transferee acknowledge that with respect to this Memorandum the only lease schedule subject to the Master Lease being assigned to, and assumed by, Transferee is Schedule #1.

WHEREAS, the Parties wish to show for the public record the existence of the aforesaid sale and assignment, and the respective interests therein of the Parties.

WHEREAS, this Memorandum may be executed in any number of identical counterparts, any or all of which may contain signatures of fewer than all of the parties but all of which taken together shall constitute a single instrument.

WHEREAS, in the event of any conflict between the provisions of this Memorandum and the provisions of the Purchase Agreement, the provisions of the Purchase Agreement shall control.

NOW, THEREFORE, the Parties agree to the foregoing recitals and agree that Transferee may, at its option and cost, file this Memorandum with the Surface Transportation Board pursuant to 49 U.S.C. Section 11301(a).




