

Memorandum of a Lease Agreement and Rider No. 6 thereto, made and entered into as of March 1, 2015, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Lessor"), and Louisiana-Pacific Corporation, a Delaware corporation ("Lessee").

WITNESSETH:


1. Lessor has agreed to furnish to Lessee, and Lessee has agreed to lease from Lessor twenty-five (25) 73-foot, 110-ton riserless deck center partition flatcars with fabricated top chords, designed for a gross rail load of 286,000 lbs., marked and numbered as set forth in Exhibit A attached hereto.
