

MEMORANDUM OF ASSIGNMENT OF LEASE

THIS MEMORANDUM OF ASSIGNMENT OF LEASE is made and entered into as of March 28, 2016, by and between BANC OF AMERICA LEASING & CAPITAL, LLC (the "Assignor") and THE HUNTINGTON NATIONAL BANK (the "Assignee"), with reference to the following:

Assignor, as Lessor, and OLIN CHLOR ALKALI LOGISTICS, INC. ("OCAL"), as Lessee, have heretofore executed that certain Railroad Equipment Lease dated as of March 29, 2012 (the "Agreement"), and, pursuant thereto, that certain Schedule No. 002 dated as of May 14, 2012 (as amended and together with all exhibits, riders and other attachments thereto, the "Schedule", and together with the Agreement, solely to the extent the Agreement is incorporated into the Schedule by reference, the "Lease"), pertaining to the railcars described therein and further described on Exhibit No. 1 attached hereto (the "Railcars").

A Memorandum of Lease dated March 29, 2012 between Assignor, as Lessor and OCAL, as Lessee, covering the Lease and the Railcars was recorded at the Surface Transportation Board (the "Board") on June 28, 2012 under Recordation No. 30206-A.

Assignor, as assignor, and Assignee, as assignee, have executed that certain Assignment and Specification of Assigned Lease Schedule dated as of March 28, 2016 to that certain Master Assignment Agreement dated as of March 6, 2003, as the same has and may be further amended and supplemented from time to time, by and between Assignor and Assignee, pursuant to which (a) Assignor has assigned to Assignee all of Assignor's rights and obligations under the Lease and Assignee has assumed from Assignor all of Assignor's rights and obligations under the Lease, in each case, solely with respect to the assigned Railcars, and (b) Assignor has sold the assigned Railcars to Assignee.

The parties hereto wish to show for public record this Memorandum of Assignment of Lease to provide notice of such assignment.

This Memorandum of Assignment of Lease relates only to the sale by Assignor to Assignee of the assigned Railcars described herein and the assignment by Assignor to Assignee of the Lease solely as it pertains to such Railcars.

This Memorandum of Assignment of Lease may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Memorandum of Assignment of Lease.


