

This MEMORANDUM OF LEASE is made and entered into as of October 30, 2015, between SunTrust Equipment Finance & Leasing Corp., a Virginia corporation ("Lessor"), and Olin Chlor Alkali Logistics, Inc., a Delaware corporation ("Lessee"), with reference to the following:


2. The Lease shall be effective as of the date hereof and shall be subject to the term specified in the Lease, and any extension of such term to the extent provided for in the Lease.






