**NOTICE OF
LEASE TERMINATION**

This Notice of Lease Termination effective as of May ~~30~~¹⁴, 2014 by SMBC Rail Services LLC, a Delaware limited liability company, as ultimate successor-in-interest to Infinity Rail, LLC (the "Lessor").

W I T N E S S E T H:

Lessor and Mosaic Crop Nutrition, LLC, a Delaware limited liability company (the "Lessee") are parties to that certain Master Lease Agreement effective as of December 1, 2010, whereby Lessor has agreed to lease to the Lessee and the Lessee has agreed to lease from Lessor certain railcars pursuant to Schedule No. 1 to Master Lease Agreement dated as of December 1, 2010 (collectively, the "Lease Agreement").

The Notification of Leases was filed with the Registrar General of Canada (the "RGC") on November 6, 2012 at 1:51 p.m., as assigned by that certain Memorandum of Assignment of Leases which was filed with the RGC on November 6, 2012 at 1:51 p.m., as further assigned by that certain Memorandum of Assignment and Assumption Agreements which was filed with the RGC on October 31, 2013 at 10:07 a.m.

Notice is hereby given that the Lease Agreement has been terminated with respect to the railroad cars as described in the Lease Agreement, as assigned by the above-referenced instruments.

This Notice of Lease Termination shall not impair nor terminate any of the rights and obligations of the parties under the Lease Agreement which, by their terms, expressly survive its termination.


