**MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASE**  
(Surface Transportation Board)

THIS MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASE (this “Memorandum”) dated as of May 21, 2015 is between MIDWEST RAILCAR CORPORATION (the “Assignor”) and MANUFACTURERS AND TRADERS TRUST COMPANY (the “Assignee”).

The parties to this Memorandum hereby acknowledge and confirm the following:

A. The Assignor, as lessor, has leased to U.S. Silica Company, as lessee (the “Lessee”), one hundred (100) Covered Hoppers identified on Schedule 1 attached hereto (the “Railcars”) under that certain Schedule #16 dated March 4, 2014, as amended by that certain First Amendment of Schedule #16 dated as of April 2, 2015, each by and between Assignor, as lessor, and Lessee, as lessee, to the Full Service Master Lease Agreement dated as of June 16, 2004, by and between Assignor, as lessor and Lessee, as lessee (collectively, as amended, the “Lease”).




