MEMORANDUM OF LEASE AGREEMENT

THIS MEMORANDUM OF LEASE AGREEMENT is made and entered into as of May 8, 2015, by and between WEDRON SILICA COMPANY ("Lessee") and THE HUNTINGTON NATIONAL BANK ("Lessor"), with reference to the following:
