MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT

THIS MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT dated as of December 12, 2014, is made by and between FIFTH THIRD BANK, ("Assignor"), and SIGNATURE FINANCIAL LLC ("Assignee").

1. Pursuant to the Master Equipment Lease Agreement, dated December 9, 2014 (the "Master Lease") and the related Equipment Schedule No. 001, dated December 9, 2014 (the "Schedule" and all riders, addenda, attachments and exhibits thereto, and together with the Master Lease shall collectively be referred to as the "Lease Agreement"), between Fifth Third Bank as Lessor and R.E.L.A.M., Inc. as Lessee, R.E.L.A.M., Inc. has agreed to lease from Fifth Third Bank the equipment set forth on Exhibit A attached hereto.
