MEMORANDUM OF LEASE

SCHEDULE NO. 8

This is a Memorandum of Schedule No. 8 dated January 2, 2015, to a Lease Agreement made and entered into as of June 1, 2014, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company, ("Lessor") and Halliburton Company, a Delaware corporation ("Lessee").

WITNESSETH:


