



PARTIAL TERMINATION OF SECURITY AGREEMENT

SURFACE TRANSPORTATION BOARD

THIS PARTIAL TERMINATION OF SECURITY AGREEMENT ("Termination") is made as of July 14th, 2015 by BOKF, NA DBA BANK OF OKLAHOMA ("Secured Party") for the benefit of WILLIAMS EQUIPMENT LEASING LLC ("Debtor").

1. Recitals:

- a. Secured Party and Debtor entered into a Commercial Security Agreement dated as of April 22, 2014 ("Agreement") pursuant to which the Secured Party acquired a security interest in certain railroad cars ("Railcars"), as more particularly described in the Agreement.
- b. Secured Party and Debtor entered into a certain Memorandum of Security Agreement ("Memorandum") evidencing the above-described Agreement, which Memorandum was filed at the Surface Transportation Board on May 6, 2014, having recordation number 31195.
- c. Certain of the Railcars, as more particularly described on Exhibit A hereto, have been released and are no longer covered by the Agreement.

2. Termination of Security Interest:

Secured Party's security interest in the specific Railcars listed on Exhibit A hereto shall be and is hereby terminated upon the filing of this Partial Termination with the Surface Transportation Board, and all of Secured Party's right, title and interest in and to said Railcars shall and has become null and void.

IN WITNESS WHEREOF, Secured Party, pursuant to due authority, has executed this Partial Termination on the date above first written.




