

RAILCAR COLLATERAL SCHEDULE TERMINATION

This Railcar Collateral Schedule Termination dated as of August 21, 2015 is between SUNTRUST EQUIPMENT FINANCE & LEASING CORP., as "Secured Party" and TRINITY CHEMICAL LEASING, L.L.C., as "Debtor."

NOW, THEREFORE, in consideration of the premises:




