

RAILCAR COLLATERAL SCHEDULE TERMINATION

This Railcar Collateral Schedule Termination dated as of August 21, 2015 is between SUNTRUST EQUIPMENT FINANCE & LEASING CORP., as "Secured Party" and TRINITY CHEMICAL LEASING, L.L.C., as "Debtor."

Secured Party and Debtor hereby acknowledge and confirm for the public record the termination of the Security Agreement, and all rights and obligations arising under the Security Agreement with respect to the Equipment.

This Railcar Collateral Schedule Termination may be executed in separate counterparts, each of which when so executed and delivered shall be an original for all purposes, but all such counterparts shall constitute but one and the same instrument.
