

February 28, 2015.

WITNESSETH

WHEREAS, GATX RAIL LOCOMOTIVE GROUP, L.L.C. ("GATX"), as lessor, and Iowa Interstate Railroad, LTD. ("Iowa Interstate"), as lessee, entered (1) a Memorandum of Lease Agreement dated as of February 20, 2007, which was recorded at the Surface Transportation Board (the "Board") on February 22, 2007 at 11:56 am under Recordation Number 26818; and (2) an Amended Memorandum of Lease Agreement date as of March 21, 2007 was recorded at the Board on March 22, 2007 at 3:56 pm under Recordation Number 26818-A, both for four SD38-2 locomotives numbered IAIS 150,151, 152 and 153 formally known as LLPX 2802, LLPX 2805, LLPX 2807 and LLPX 2809, respectively (the "Locomotives") pursuant to that certain Locomotive Lease Agreement dated as of May 25, 2004 between GATX and Iowa Interstate (the "Lease"); and

GATX does hereby acknowledge and confirm for the public record the satisfaction and release of all rights and obligations arising under the Lease with respect to the Locomotives.


