TO LEASE AGREEMENT

Memorandum of Schedule No. 24 dated as October 13th, 2014, and effective September 7, 2014, to a Lease Agreement made and entered into May 9, 2011 and effective October 1, 2010, and amended effective July 31, 2013, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Lessor") and EOG Resources, Inc., a Delaware corporation ("Lessee").


