THIS MEMORANDUM OF ASSIGNMENT dated as of February 28, 2014, is between GREENBRIER LEASING COMPANY LLC, an Oregon limited liability company ("Greenbrier"), and WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association ("WFB").

The parties to this Memorandum hereby acknowledge and confirm the following:

A. Greenbrier, as lessor, has leased certain railroad cars more particularly described on Schedule 1 attached hereto (the "Cars") pursuant to that certain Lease Agreement dated as of August 6, 2013 and effective November 1, 2011, and Schedule No. 1 thereto (as amended, modified, extended, supplemented, restated and/or replaced from time to time, the "Lease") to Pinnacle Renewable Energy Inc.






