

MEMORANDUM OF SCHEDULE NO. 2

DATED: MARCH 1, 2015

TO LEASE AGREEMENT

DATED: AUGUST 15, 2012

BETWEEN

GREENBRIER LEASING COMPANY LLC ("LESSOR")

AND

MOUNTAIN WEST, L.L.C. ("LESSEE")

Memorandum of Schedule No. 2 dated as of March 1, 2015, to a Lease Agreement made and entered into as of August 15, 2012 by and between Greenbrier Leasing Company LLC, an Oregon limited liability company, ("Lessor") and Mountain West, L.L.C., an Idaho limited liability company ("Lessee").

WITNESSETH:

1. Lessor has agreed to furnish to Lessee, and the Lessee has agreed to lease from Lessor ten (10) used 6,000 cubic foot to 6,007 cubic foot woodchip gondola railcars bearing reporting marks and numbers as set forth in the Rail Equipment List attached hereto as Exhibit A.
2. Schedule No. 2 to the Lease Agreement will be effective as of the date first set forth hereinabove and will remain in effect through the lease term, as described in the Lease Agreement and Schedule No. 2, as each may be amended from time to time.


