This **MEMORANDUM OF COLLATERAL ASSIGNMENT OF LEASE AGREEMENT** (“Assignment”) is made effective as of September 1, 2015 by and between The Andersons, Inc. (“Assignor”) and Siemens Financial Services, Inc. (“Assignee”).


