

Siemens is a party to such a Collateral Schedule. Trinity Leasing, SunTrust and Siemens hereby agree that the Master Security Agreement is hereby amended as follows: in the definition of the term "Collateral", the phrase "TCLX 209201-209500" is hereby deleted and replaced with the phrase "TCLX 290201-290500".
2. Reference is hereby made to that certain Railcar Collateral Schedule No. SIE-001 dated as of July 17, 2015 ("**Schedule SIE-001**"), by and between Siemens and Trinity Leasing. Siemens and Trinity Leasing hereby agree that each reference in Schedule SIE-001 to "209211" is hereby deleted and replaced with a reference to "290211". (CDN 80)
3. Reference is hereby made to that certain Lease Schedule No. 001 dated as of June 12, 2015 ("**Schedule 001**"), by and between Trinity Leasing and Trinity Industries. Trinity Leasing and Trinity Industries hereby agree that each reference in Schedule 001 to "209211" is hereby deleted and replaced with a reference to "290211". (CDN 16)
4. Reference is hereby made to the following documents (the "**Recorded Documents**"):
 - (a) Memorandum of Lease Schedule 001 dated as of June 12, 2015, by and between Trinity Leasing and Trinity Industries, and recorded with the Surface Transportation Board on June 12, 2015 at 01:17 PM as Recordation No. 31770-A, as amended by Amendment to Memoranda dated as of July 2, 2015, among SunTrust, Trinity Leasing and Trinity Industries, and recorded with the Surface Transportation Board on July 2, 2015 at 2:36 PM as Recordation No. 31785-D, and registered with the Registrar General of Canada (the "**Registrar**") on June 12, 2015 (CDN 17);
 - (b) Memorandum of Railcar Collateral Schedule dated as of July 17, 2015, by and between Siemens and Trinity Leasing, and recorded with the Surface Transportation Board on July 17, 2015 at 4:56 pm as Recordation No. 31820, and registered with the Registrar on July 17, 2015 (CDN 81);
 - (d) Memorandum of Collateral Assignment of Lease Schedules 001, 002 and 003 dated as of July 17, 2015, by and between Trinity Leasing and Siemens, and recorded with the Surface Transportation Board on July 17, 2015 at 4:58 pm as Recordation No. 31820-A and registered with the Registrar on July 17, 2015 (CDN 85); and

(e) Memorandum of Collateral Assignment of Master Railcar Services Agreement dated as of July 17, 2015, by and between Trinity Industries and Siemens, and recorded with the Surface Transportation Board on July 17, 2015 at 5:00 pm as Recordation No. 31820-B and registered with the Registrar on July 17, 2015 (CDN 87-A).

2. SunTrust, Siemens, Trinity Leasing and Trinity Chemical hereby agree that each reference to "209211" in the Recorded Documents are hereby deleted and replaced with the reference "290211".

This Amendment may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Amendment to Documents and Memoranda.






