PARTIAL RELEASE OF SECURITY INTEREST

The undersigned, acting on behalf of DVB BANK SE (formerly known as DVB BANK AG), as Secured Party (the "Secured Party"), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, does hereby terminate, release and discharge any and all security interests held by it on all railroad equipment and leases thereon described in Schedule A (the "Released Equipment") attached, granted to it as Agent pursuant to the Loan and Security Agreement, dated as of March 20, 2007 (the "Security Agreement"), as amended, modified and supplemented, between Compass Rail VI Corporation, as Assignor and the Secured Party.


