MEMORANDUM OF ASSIGNMENT OF LEASE

This MEMORANDUM OF ASSIGNMENT OF LEASE (this “Memorandum”) is made and entered into as of August 26, 2015, by and between WINTRUST COMMERCIAL FINANCE, a Division of Beverly Bank & Trust Company, National Association (“Assignee”), and KEY EQUIPMENT FINANCE, a Division of KeyBank National Association (“Assignor”).

1. Assignor, as lessor, and PBF Holding Company LLC, a Delaware limited liability company, as lessee, have executed that certain Rail Equipment Net Leasing Agreement dated as of December 31, 2014, and, pursuant thereto, that certain Schedule No. 009 dated August 26, 2015 (collectively, the “Lease”), pertaining to the railcars set forth therein and further described on Exhibit A attached hereto (the “Units”).
2. Assignor, as assignor, and Assignee, as assignee, have executed that certain (a) Master Assignment Agreement dated as of June 23, 2015, and (b) that certain Specification of Assigned Schedule to the Master Assignment Agreement dated as of the date hereof, pursuant to which (i) Assignor has assigned to Assignee all of Assignor’s rights and obligations under the Lease and Assignee has assumed from Assignor all of Assignor’s rights and obligations under the Lease, in each case, solely with respect to the assigned Units, and (ii) Assignor has sold the assigned Units to the Assignee.
3. Assignor, as lessor, filed a Memorandum of Lease Agreement with the Surface and Transportation Board on August 26, 2015 with respect to the Units. Such filing is awaiting a Recordation Number. The parties hereto wish to show for public record this Memorandum to provide for notice of such assignment.
4. This Memorandum relates only to the sale by Assignor to Assignee of the assigned Units described herein and the assignment by Assignor to Assignee of the Lease solely as it pertains to such Units.

This Memorandum may be executed in any number of counterparts, by different parties hereto in separate counterparts and by facsimile or other electronic signature, each of which when so executed and delivered shall be deemed to be an original and all of which taken together shall constitute but one and the same agreement.
