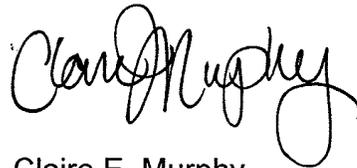

A. Greenbrier, as lessor, has leased one hundred eighty-one (181) Multi-Max™ auto racks in bi-level configuration with grating system on two (2) decks, including Zeftek chocks and door edge protection, marked and numbered BNSF 27369 through BNSF 27549, inclusive (the "Cars"), pursuant to that certain Master Full Service Railcar Lease dated as of October 12, 2006, effective as of June 1, 2006, as amended effective December 2, 2008 (the "Lease Agreement"), and Schedule No. 25 thereto dated as of July 16, 2015 (the "Schedule", and together with the Lease Agreement as it relates to the Schedule, the "Lease") to BNSF Railway Company.
