

TERMINATION OF LEASE

THIS TERMINATION OF LEASE is made as of June 29, 2015 by Wells Fargo Bank, National Association, as successor by merger to Wachovia Financial Services, Inc. ("Wells Fargo"), as lessor.

WITNESSETH:

WHEREAS, a Memorandum of Lease Agreement dated as of November 8, 1997 (the "Lease") among Citicorp Railmark, Inc. ("Citicorp"), as lessor, Winchester & Western Railroad Company, as lessee, and Unimin Corporation, as guarantor, was recorded at the Surface Transportation Board (the "Board") at 10:34 am on November 25, 1997 under Recordation No. 21025 for 223 covered hopper cars numbered WW 3001-3050, inclusive, 3052-3090, inclusive, and 3092-3225, inclusive; and

WHEREAS, a Memorandum of Assignment of Lease dated as of December 23, 2004 between Citicorp, as transferor, and Banc of America Capital & Leasing, LLC ("BALC"), as transferee, was recorded at the Board at 3:43 pm on December 28, 2004 under Recordation No. 21025-A for 216 covered hopper cars numbered WW 3001-3005, inclusive, 3007, 3009-3049, inclusive, 3052-3068, inclusive, 3070-3097, inclusive, 3099-3184, inclusive, 3186-3190, inclusive, and 3193-3225, inclusive; and

WHEREAS, a Memorandum of Assignment and Assumption Agreement dated as of May 31, 2006 between BALC, as assignor, and Wells Fargo, as assignee, was recorded at the Board at 1:53 pm on July 14, 2006 under Recordation No. 21025-B for 216 covered hopper cars numbered WW 3001-3005, inclusive, 3007, 3009-3049, inclusive, 3052-3068, inclusive, 3070-3097, inclusive, 3099-3184, inclusive, 3186-3190, inclusive, and 3193-3225, inclusive (the "Equipment"); and

WHEREAS, the duties and obligations of the parties to the Lease have been satisfied and discharged with respect to the Equipment.

NOW, THEREFORE, in consideration of the promises and covenants in the documents set forth above by reference, and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and the authority to issue and execute this document, intending to be legally bound, and recognizing the need to officially terminate the Lease of the Equipment in the files of the Board, Wells Fargo hereby terminates and cancels the Lease of the Equipment as of the date herein first written above; provided that this termination does not apply to provisions of the Lease stated to survive such termination.
