**MEMORANDUM OF TERMINATION AND RELEASE AGREEMENT  
(UTC TRUST NO. 1992-A)  
(L-7K, L-8K AND L-9K)**

THIS MEMORANDUM OF TERMINATION AND RELEASE AGREEMENT is made and entered into as of December 30, 2014 by and among UNION TANK CAR COMPANY, a Delaware corporation (the "*Lessee*"); U.S. BANK NATIONAL ASSOCIATION, a national banking association, not in its individual capacity, but solely as trustee (in its individual capacity, the "*Trust Company*" and not in its individual capacity, but solely in its trustee capacity, the "*Owner Trustee*" or "*Lessor*"); KEY EQUIPMENT FINANCE, A DIVISION OF KEYBANK NATIONAL ASSOCIATION (successor-in-interest to KeyCorp Leasing, Ltd.), a national banking association (the "*Owner Participant*"); THE BANK OF NEW YORK MELLON TRUST COMPANY N.A. (successor-in-interest to NationsBank of South Carolina), a national banking association, not in its individual capacity, but as trustee under each Indenture (the "*Indenture Trustee*") and as trustee under each Pass Through Trust Agreement.

1. The Owner Participant and the Owner Trustee are parties to (i) that certain Trust Agreement (L-7K) (UTC Trust No. 1992-A) dated as of June 24, 1992 pursuant to which the Owner Trustee holds legal title to the 50 Non-Pressure/General Purpose Cars described therein (the "*7-K Units*" or the "*7-K Equipment*"), (ii) that certain Trust Agreement (L-8K) (UTC Trust No. 1992-A) dated as of June 24, 1992 pursuant to which the Owner Trustee holds legal title to the 67 Pressure Cars (33,800 Gallons) described therein (the "*8-K Units*" or the "*8-K Equipment*") and (iii) that certain Trust Agreement (L-9K) (UTC Trust No. 1992-A) dated as of June 24, 1992 pursuant to which the Owner Trustee holds legal title to the 63 Other Pressure Cars described therein (the "*9-K Units*"; together with the 7-K Units and the 8-K Units, the "*Units*" or the "*9-K Equipment*"; together with the 7-K Equipment and the 8-K Equipment, the "*Equipment*").

2. The Lessor and Lessee are parties to (i) that certain Equipment Lease Agreement (7-K) (UTC Trust No. 1992-A), dated as of June 30, 1992 (as amended, modified and/or supplemented, the "*7-K Equipment Lease*") pursuant to which Lessee leased the 7-K Units from Lessor (which 7-K Equipment Lease was recorded with the Surface Transportation Board ("*STB*") on June 30, 1992, under recordation number 17844 and deposited with the Registrar General of Canada (the "*RGC*") in Ontario on June 30, 1992), (ii) that certain Equipment Lease Agreement (8-K) (UTC Trust No. 1992-A), dated as of June 30, 1992 (as amended, modified and/or supplemented, the "*8-K Equipment Lease*") pursuant to which Lessee leased the 8-K Units from Lessor (which 8-K Equipment Lease was recorded with the STB on June 30, 1992, under recordation number 17845 and deposited with the RGC on June 30, 1992) and (iii) that certain Equipment Lease Agreement (9-K) (UTC Trust No. 1992-A), dated as of June 30, 1992 (as amended, modified and/or supplemented, the "*9-K Equipment Lease*"; together with the 7-K Equipment Lease and the 8-K Equipment Lease, the "*Equipment Leases*" and each an "*Equipment Lease*") pursuant to which Lessee leased the 9-K Units from Lessor (which 9-K Equipment Lease was recorded with the STB on June 30, 1992, under recordation number 17846 and deposited with the RGC on June 30, 1992).

3. The Owner Trustee and the Indenture Trustee are parties to (i) that certain Indenture and Security Agreement (UTC Trust No. 1992-A) (L-7K) dated as of June 30, 1992 (as amended, modified and/or supplemented, the "7-K Indenture") (which 7-K Indenture was recorded with the STB on June 30, 1992, under recordation number 17844-A and deposited with the RGC on June 30, 1992 and July 10, 1992), (ii) that certain Indenture and Security Agreement (UTC Trust No. 1992-A) (L-8K) dated as of June 30, 1992 (as amended, modified and/or supplemented, the "8-K Indenture") (which 8-K Indenture was recorded with the STB on June 30, 1992, under recordation number 17845-A and deposited with the RGC on June 30, 1992 and July 10, 1992) and (iii) that certain Indenture and Security Agreement (UTC Trust No. 1992-A) (L-9K) dated as of June 30, 1992 (as amended, modified and/or supplemented, the "9-K Indenture"; together with the 7-K Indenture and the 8-K Indenture, the "Indentures" and each an "Indenture") (which 9-K Indenture was recorded with the STB on June 30, 1992, under recordation number 17846-A and deposited with the RGC on June 30, 1992 and July 10, 1992).

4. The Lessee and the Pass Through Trustee are parties to (i) that certain Pass Through Trust Agreement 1992-A1 dated as of June 24, 1992 and (ii) that certain Pass Through Trust Agreement 1992-A2 dated as of June 24, 1992 (in each case, as amended, supplemented or modified to date, a "Pass Through Trust Agreement" and collectively, the "Pass Through Agreements").

5. The Pass Through Trustee and the Indenture Trustee each acknowledges that, prior to the date hereof, (i) all of the Equipment Notes issued pursuant to the terms of each Indenture have been repaid in full, (ii) all amounts required to be distributed to the holders of the Pass Through Certificates issued pursuant to each Pass Through Agreements have been made and (iii) subject to Section 7 below, each Indenture and each Pass Through Trust Agreement have been terminated and the lien in and on the Equipment pursuant to the terms thereof is discharged and released.

6. The undersigned parties do hereby give notice of the termination of each Lease, each Indenture and each of other Operative Agreements (as defined in each Lease) effective as of the date hereof with respect to the Equipment subject thereto.

7. This Memorandum of Termination and Release Agreement shall neither impair nor terminate the rights, obligations, liabilities, duties or claims and demands of the parties pursuant to any indemnification provision under the Lease, the Indenture or the other Operative Agreements which expressly survive this termination by its terms.


