AMENDMENT TO ASSIGNMENT OF LEASE AND AGREEMENT dated

NOW, THEREFORE, the parties hereto hereby amend the Lease Assignment as follows:


1. Each reference to the Lease shall mean the Lease as amended by the Amendment to Lease.






