With reference to our telephone conversation, we are submitting this Amendment to our March 31, 1971, lease of 55-Thrall-Door cars to cover increases in maintenance costs. This amendment supercedes S. D. Christianson's letter to you dated July 27, 1978. We would appreciate your executing the attached five (5) copies of this letter and returning them to us for filing.

AMENDMENT

- a) Paragraph 1, line 9;
delete 50, insert 48.
- b) Paragraph 1, line 12;
delete MD&W 3005 thru 3054, both incl.
insert MD&W 3005, 3007 thru 3043, both incl.
and 3045 thru 3054, both incl.
- c) Paragraph 1, line 20;
1) delete 55 cars, insert 53 cars; and
2) delete \$302 per month, as amended by letter
on December 10, 1973, and insert \$370 per month.

d) Add the following paragraph:


ADDITIONAL
PROVISIONS

18. If any of the cars become unfit for service and are returned to Transportation's Home Shop (Thrall Car Manufacturing Company, Chicago Heights, Illinois) for service and shall be held in Thrall's Shop for repairs and shall remain therein for a period in excess of five (5) days, the monthly rental will be credited \$3.29 per car, per day, from and after such period of five (5) days until such car is released from Thrall to the Lessee.

We will return a recorded copy to you after filing.




