SUPPLEMENTAL AGREEMENT

INTERSTATE COMMERCE COMMISSION

THIS SUPPLEMENTAL AGREEMENT dated as of April 1, 1972, by and between FIRST NATIONAL CITY BANK, a national banking association incorporated and existing under the laws of the United States of America and having its principal Corporate Trust Office at 111 Wall Street, New York, New York 10015, as Trustee (hereinafter called the Trustee), and BURLINGTON NORTHERN INC., a corporation duly organized and existing under the laws of the State of Delaware (hereinafter called the Company).

WHEREAS, the Trustee and the Company have entered into, executed and delivered that certain Equipment Trust Agreement dated as of December 1, 1971 (the Agreement); and

WHEREAS, pursuant to said Agreement the Company has agreed to cause to be sold, assigned and transferred to the Trustee the Trust Equipment described in Schedule A thereto; and

WHEREAS, pursuant to Section 4.01 of the Agreement, the Company deems it desirable to procure for the use of the Company, and to include in the trust created by the Agreement, certain Equipment in lieu of certain other Equipment specifically

described in Schedule A thereto;

NOW, THEREFORE, it is hereby agreed:

1. Schedule A of said Equipment Trust Agreement dated as of December 1, 1971, by and between the Trustee and the Company, is hereby amended by deleting the following Equipment therefrom:


2. All other terms, conditions, covenants and agreements of said Equipment Trust Agreement dated as of December 1, 1971 by and between the Trustee and the Company are to remain the same.

3. The Trustee shall not be responsible in any manner whatsoever for or in respect of the validity or sufficiency of this Supplemental Agreement or the due execution hereof by the Company or for or in respect of the correctness of the recitals of fact contained herein, which recitals are made by the Company.

4. This Supplemental Agreement may be executed simultaneously, or from time to time, in several counterparts and each counterpart shall constitute a complete original instrument, and it shall not be necessary in making proof of this Supplemental Agreement or any counterpart hereof to produce or account for any of the other counterparts.




