AMENDMENT AGREEMENT NO. 1 dated as  
of October 1, 1979, between ACF  
INDUSTRIES, INCORPORATED (herein-  
after called the Manufacturer) and  
TRAILER TRAIN COMPANY (hereinafter  
called the Company).

WHEREAS, the Manufacturer and the Company have entered into a Manufacturing Agreement dated as of May 1, 1978, filed and recorded with the Interstate Commerce Commission pursuant to 49 U.S.C. § 11303(a) on May 3, 1978, at 11:40 A.M., recordation number 9363, as supplemented as of November 15, 1978, recorded November 22, 1978, at 11:15 A.M., recordation number 9363-A, and as supplemented as of January 30, 1979, recorded January 30, 1979, at 3:50 P.M., recordation number 9363-B, and as supplemented as of August 15, 1979, recorded August 16, 1979, at 10:50 A.M., recordation number 9363-C; and

WHEREAS, the parties hereto desire to amend the Manufacturing Agreement:

NOW, THEREFORE, in consideration of the mutual agreements herein contained, the parties hereto agree as follows:

1. The Manufacturing Agreement is hereby amended to delete from Annex A thereto as supplemented, seventy-five (75), 89'4" 70-ton capacity, hydraulic draft gear, flush deck, all-purpose flat cars numbered 974861 through 974935.

2. The Manufacturing Agreement, except as amended hereby, shall remain unaltered and in full force and effect.

3. The Company will promptly cause this Amendment Agreement to be filed and recorded with the Interstate Commerce Commission pursuant to 49 U.S.C. § 11303 (a).




