SUPPLEMENTAL SECURITY AGREEMENT

JUN 29 1979 -4 30 PM

INTERSTATE COMMERCE COMMISSION

This FIRST SUPPLEMENTAL SECURITY AGREEMENT dated as of June 29, 1979 is between MERCANTILE TRUST COMPANY NATIONAL ASSOCIATION, a national banking association, not individually but solely as a trustee (the "Debtor") under a Trust Agreement dated as of June 15, 1979 with BameriLease Inc., a California corporation, and The First National Bank of Kansas City (the "Security Trustee").

WHEREAS, the Debtor and the Security Trustee have entered into a certain Security Agreement dated as of June 15, 1979 (the "Security Agreement", the defined terms therein being used herein with the same meanings) and recorded as document #10505 in the records of the Interstate Commerce Commission on June 15, 1979, which Security Agreement provides, among other things, for a security interest in certain Items of Equipment of the Debtor to secure the payment of principal and interest on the Notes;

WHEREAS, the Debtor and the Security Trustee desire to provide additional security for the holders of the Notes; and

WHEREAS, Section 8.11 of the Security Agreement provides for the execution of a Supplemental Security Agreement for the purpose of subjecting additional property acquired by the Debtor to the security interest of the Security Agreement;

NOW, THEREFORE, in order to amend the Description of Equipment set forth in Schedule 2 to the Security Agreement and to subject additional items of equipment to be financed with the proceeds of the Notes to the security interest of the Security Agreement, the parties hereto agree as follows:

1. The Description of Equipment attached hereto as Schedule 2 shall be substituted for Schedule 2 of the Security Agreement.

2. Except as set forth in paragraph 1 hereto, all of the provisions of the Security Agreement are hereby ratified, confirmed and agreed to.

3. This First Supplemental Security Agreement is being delivered in the State of Missouri and shall in all respects be governed by, and construed in accordance with, the laws of the State of Missouri; provided, however, that the parties shall be entitled to all rights conferred by any applicable Federal statute, rule or regulation.
