And the Agent hereby warrants to the Railroad, its successors and assigns that the Agent has legal title to the Equipment and good and lawful right to sell the Equipment, and that title to the Equipment is free of all claims, liens and encumbrances of any nature, other than claims, liens and encumbrances resulting from actions of parties in possession of the Equipment. Agent makes no warranty as to the merchantability of fitness of any particular piece of the Equipment.
