RELEASE AND ASSIGNMENT

INTERSTATE COMMERCE COMMISSION

In consideration of \$9,714,375.00 and other valuable consideration, Pullman Incorporated (Pullman Standard Division), a Delaware corporation (the "Manufacturer"), the manufacturer under a Conditional Sale Agreement dated as of December 8, 1978 and Amendment dated as of December 21, 1978 (herein the "Conditional Sale Agreement") with ITEL CORPORATION, a Delaware corporation acting through its Rail Division (ITEL CORPORATION-Rail Division), recorded on December 12, 1978 and January 2, 1979 with the Interstate Commerce Commission as Recordation Nos. 9901 and 9901-A respectively, hereby releases all liability or other obligation which ITEL CORPORATION may have under the Conditional Sale Agreement. Further, the Manufacturer hereby assigns to ITEL CORPORATION all of the Manufacturer's right, title and interest in and to 275 70-Ton 50'6" Box Cars, numbered NOPB 3500-3774 inclusive, which cars are covered by the Conditional Sale Agreement.
