

STATEMENT OF OWNERSHIP

INTERSTATE COMMERCE COMMISSION

This STATEMENT OF OWNERSHIP made as of the first day of April, 1978, by RAILWAY FREIGHT CAR SERVICES, INC., a Delaware Corporation, ("RFC") as the registered lessor in a lease heretofore entered into by and between RAILWAY FREIGHT CAR SERVICES, INC. and the ERIE WESTERN RAILWAY, and Indiana Corporation and TRANS-ACTION ASSOCIATES, INC., dated March 1 wherein RFC appears as the lessor of fifty (50) 70 TON 50 FOOT XF boxcars; and

WHEREAS, RFC in entering into such agreement was acting as the agent of, and on behalf of the actual owners of the cars and pursuant to management agreements heretofore entered into by and between RFC and the various owners;

NOW, THEREFORE, RFC does hereby covenant and agree that the following named individuals are, and at all times have been vested with the full ownership and title to the 70 Ton 50 Foot XF boxcars bearing the markings set forth beside their names and that RFC claims no ownership of any type of said boxcars. RFC further covenants that, in accordance with the management agreements heretofore executed, it shall act solely as agent and on behalf of the actual owners of the cars described herein.
