SUBLEASE

WHEREAS, UNITED STATES RAILWAY LEASING COMPANY ("United") and EVANS PRODUCTS COMPANY ("Evans") have hereby entered into that certain lease dated February 26th, 1973 ("Lease") providing for the lease by United to Evans of 75 cars bearing car reporting marks USLX 50000 through 50074, both inclusive; and

WHEREAS, the Lease was recorded with the Interstate Commerce Commission pursuant to Section 20c of the Interstate Commerce Act as Recordation No. 6998; and

WHEREAS, Evans desires to sublease 15 cars bearing car reporting marks USLX 50010 through 50024, both inclusive, (the "Sublet Cars") to United, and United is willing so to do, and upon the terms and conditions herein provided.

NOW, THEREFORE, in consideration of the premises and the covenants and conditions herein set forth the parties agree as follows:

1. Evans hereby subleases to United and United hereby subleases from Evans the Sublet Cars for the remainder of the term of the Lease above described.

2. Except as hereinafter provided all of the terms and conditions of the Lease are hereby incorporated herein and by this reference made a part hereof as if United were the lessee and Evans the lessor.

3. United agrees to pay Evans as rental for the Sublet Cars the rental per car per month provided for in the

Lease by crediting the amount of said rental against the amount due United from Evans as rental for the Cars under the Lease.

4. All other sums due and payable to Evans by reason of Paragraph 2 hereof shall be retained by United and credited against the like amounts due and payable to United under the Lease.

5. United agrees to perform or cause to be performed all Repair Work required to be performed under the Sublease.

6. Nothing in this contract shall constitute a merger of this Sublease or the interests of the parties herein with the Lease or the interests of the parties therein, and this Sublease shall constitute for all intents and purposes a separate and distinct agreement of the parties binding and enforceable in accordance with its particular terms.
