THIS THIRD SUPPLEMENTAL EQUIPMENT TRUST AGREEMENT (the "Supplemental Agreement") dated August 20, 1974, by and between UNION TANK CAR COMPANY, a corporation duly organized and existing under the laws of the State of Delaware (the "Company"), and UNITED STATES TRUST COMPANY OF NEW YORK, a corporation duly organized and existing under the laws of the State of New York, as Trustee (the "Trustee").

WITNESSETH:

WHEREAS, the Company has heretofore executed and delivered to the Trustee an Equipment Trust Agreement dated July 1, 1970 (the "Trust Agreement"), providing for an issue of its Equipment Trust Certificates (Series 6) (the "Trust Certificates"), in aggregate principal amount of \$25,000,000;

WHEREAS, pursuant to Section 5.07 of the Trust Agreement, each unit of Trust Equipment (as defined in the Trust Agreement) is required to have affixed to it plates or marks containing the words set forth in said Section 5.07 (the "Legend");

WHEREAS, the Company desires to be able to use an alternative legend (the "Alternative Legend") for such plates or marks containing the following words:

"OWNERSHIP SUBJECT TO A SECURITY AGREEMENT RECORDED UNDER SECTION 20c OF THE INTERSTATE COMMERCE ACT"; and

WHEREAS, the Company and the Trustee desire to provide for the use of the Alternative Legend by the execution of a supplement to the Trust Agreement;

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt whereof is hereby acknowledged, the Company covenants and agrees with the Trustee as follows:

ARTICLE ONE

Use of Legend or Alternative Legend

The plates or marks required to be affixed to each unit of Trust Equipment pursuant to Section 5.07 of the Trust Agreement may contain the words of either or both the Legend or the Alternative Legend.

ARTICLE TWO

Concerning the Trustee

The Trustee accepts the provisions of this Supplemental Agreement but only upon the terms and conditions set forth in the Trust Agreement as amended. The Trustee makes no representations and shall have no responsibility as to the validity of this Supplemental Agreement.

ARTICLE THREE

Miscellaneous

Except as herein expressly provided, the Trust Agreement is in all respects ratified and confirmed and all the terms, provisions and conditions thereof shall be and remain in full force and effect.

This Supplemental Agreement may be executed in any number of counterparts, each of which shall be an original, but such counterparts shall together constitute but one and the same instrument.


