

THIS SUPPLEMENTAL CONTRACT, made as of February 18, 1975, among AMERICAN ELECTRIC POWER SERVICE CORPORATION, a New York corporation (herein called "AEP"), OHIO POWER COMPANY, an Ohio corporation (herein called "Designated Purchaser"), and GREENVILLE STEEL CAR COMPANY, a Pennsylvania corporation (herein called "Seller"),

W I T N E S S E T H ,

T H A T :

1. Pursuant to the Contract dated January 31, 1975 (herein called the "Original Contract"), between AEP and Seller, AEP hereby designates Ohio Power Company as the Purchaser for all purposes under the Original Contract with respect to the first Three Hundred Seventy Three (373) Cars, as defined in the Original Contract, built by Seller and accepted by Designated Purchaser thereunder. Such cars will be numbered AEPX-1501 to AEPX-1873, both inclusive (herein called the "Designated Cars").


2. Seller hereby approves of Designated Purchaser as the Purchaser under the Original Contract of the Designated Cars.

3. With respect to the Designated Cars, Designated Purchaser hereby agrees to be the Purchaser under the Original Contract as if originally named therein and to be bound by each and every provision thereof applicable to Purchaser.


4. Designated Purchaser agrees to cause this Supplemental Contract to be filed and recorded with the Interstate Commerce Commission in accordance with Section 20C of the Interstate Commerce Act.

5. It is hereby understood and agreed that this Supplemental Contract shall be applicable only to the Designated Cars and that AEP shall remain as the Purchaser under the Original Contract with respect to the remaining Cars covered thereby until an operating company of the American Electric Power System is designated and approved by Seller.




