SUPPLEMENTAL AGREEMENT dated as of October 15, 1973, between THE CHESAPEAKE AND OHIO RAILWAY COMPANY, a Virginia corporation (hereinafter called C&O), and THE BALTIMORE AND OHIO RAILROAD COMPANY, a Maryland corporation (hereinafter called B&O).

WHEREAS, C&O is the conditional purchaser from The Equitable Trust Company, a Maryland corporation (hereinafter called the Seller), pursuant to the Purchase Contract and Conditional Sale Agreement dated as of July 1, 1972 (hereinafter called the Conditional Sale Agreement), among the Seller, C&O, B&O, and The Equitable Life Assurance Society of the United States, a New York corporation (hereinafter called the Lessor), of 303 used locomotives (hereinafter called the Locomotives), previously delivered and leased by the Lessor to B&O, bearing B&O markings and road numbers, pursuant to nine Leases of Railroad Equipment, as respectively supplemented and extended (hereinafter called the Leases), of record with the Interstate Commerce Commission, all as set forth in Schedule A to the Conditional Sale Agreement; and

WHEREAS, the Leases were terminated as of June 30, 1972, by the Lessor and B&O and the Locomotives immediately thereafter became subject to all the terms and provisions of the Conditional Sale Agreement; and

WHEREAS, pursuant to an Agreement dated as of July 1, 1972 (hereinafter called the Agreement), C&O sold to B&O and B&O purchased from C&O, the Locomotives, on the terms and conditions set forth in the Agreement, subject to the Conditional Sale Agreement; and

WHEREAS, B&O now desires to effect a change of identifying road numbers of seven (7) of the Locomotives subject to the Agreement, and C&O

hereby consents thereto;

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises, covenants and agreements hereinafter set forth, it is hereby agreed between the parties hereto as follows:

(1) Schedule A to the Agreement is hereby amended by changing the road numbers of seven (7) of the Locomotives as follows:

(2) B&O at its expense will promptly cause this Supplemental Agreement to be filed, recorded or deposited with the Interstate Commerce Commission.

(3) Except as amended and supplemented hereby, the Agreement shall remain unaltered and in full force and effect.
