



AMENDMENT AGREEMENT dated as of December 1, 1972, among Third National Bank in Nashville ("Owner"), National Bank of North America ("Lender") and Chicago, Rock Island and Pacific Railroad Company ("Lessee").

WHEREAS Owner and Lessee have entered into an Equipment Lease Agreement dated as of December 1, 1972 ("Lease") covering the lease of thirteen Vert-A-Pac superstructures, Owner and Lender have entered into an Assignment of Lease and Agreement dated as of December 1, 1972 ("Assignment of Lease") and Lessee has executed a Lessee's Consent and Agreement to Lease Assignment ("Lessee's Consent") dated as of December 1, 1972; and

WHEREAS the Owner and Lender have entered into a Security Agreement dated as of December 1, 1972 ("Security Agreement") relating to the said thirteen Vert-A-Pac superstructures; and

WHEREAS the Security Agreement, Assignment of Lease and Agreement and Equipment Lease have been filed and recorded with the Interstate Commerce Commission pursuant to Section 20c of the Interstate Commerce Act on December 20, 1972 as recordation numbers 6836, 6836-A, and 6837 respectively; and

WHEREAS the parties hereto now desire to amend the Lease and the Security Agreement;

NOW THEREFORE, in consideration of the mutual covenants and agreements herein contained, the parties hereto hereby agree as follows:

1. Schedule A to the Lease and Attachment No. 1 to the Security Agreement are hereby amended by changing the description of the car numbers to which the Vert-A-Pac super-structures referred to therein are attached by deleting the number "TTV-X 802195 TTV-X 802198" as is contained in said Schedule A and Attachment No. 1, respectively, and inserting in lieu thereof the numbers "TTV-X 802171, TTV-X 802196-TTV-X 802198".

2. Owner and Lender as parties to the Assignment of Lease hereby acknowledge, confirm and agree to the foregoing amendment to the Lease and Lessee as party to the Lessee's Consent hereby acknowledges, confirms and agrees to the foregoing amendment to the Lease.

3. The Lessee will promptly cause this Amendment Agreement to be filed, recorded and deposited with the Interstate Commerce Commission in like manner as the Lease, Assignment of Lease and Security Agreement.

4. Except as amended hereby, the Lease, Assignment of Lease and Security Agreement shall remain unaltered and in full force and effect.

5. This Amendment Agreement may be executed in counterparts and it shall not be necessary for each party to execute the same counterpart so long as each party shall have

executed and delivered one counterpart, but all such counterparts shall together constitute but one and the same instrument.




