AMENDMENT AGREEMENT dated as of June 1, ~~1972~~¹⁹⁷³, among PULLMAN INCORPORATED (Pullman-Standard division) (hereinafter called the Manufacturer), BANKERS TRUST COMPANY, acting as trustee under a Trust Agreement dated as of December 1, 1972 (hereinafter called the Company), and TRAILER TRAIN COMPANY (hereinafter called the Lessee).

INTERSTATE COMMERCE COMMISSION

WHEREAS the Manufacturer, the Company and the Lessee have entered into a Manufacturing Agreement dated as of December 1, 1972 (hereinafter called the Manufacturing Agreement), filed and recorded with the Interstate Commerce Commission pursuant to Section 20c of the Interstate Commerce Act on January 15, 1973, recordation number 6845-C; and

WHEREAS the parties hereto desire to amend the Manufacturing Agreement;

NOW, THEREFORE, in consideration of the mutual agreements herein contained, the parties hereto agree as follows:

1. The Manufacturing Agreement is hereby amended to substitute the date "June 1, 1973" for the date "July 1, 1973" in the third recital clause thereof.
2. The Manufacturing Agreement is hereby amended

to substitute for the third and fourth paragraphs of Article 3 thereof the following:

"Subject to the provisions of Article 4 hereof, the Company hereby promises to pay or cause to be paid in cash to the Manufacturer at such place as the Manufacturer may designate, (i) on the Closing Date with respect to the Group, an amount equal to the Purchase Price of all units of the Equipment in the Group as set forth in the invoice or invoices therefor (such invoiced prices being herein called the Invoiced Purchase Prices) and (ii) on July 2, 1973, if the Closing Date is later than the 31st day following the date of delivery and acceptance of a unit pursuant to Article 2 hereof, interest (computed on the basis of a 360-day year of twelve 30-day months) on the Invoiced Purchase Price of such unit from such 31st day to and including the Closing Date, at a rate per annum equal to the prime rate which Manufacturers Hanover Trust Company, New York, New York, would charge at 11:00 a.m. on May 1, 1973, for 90-day loans to borrowers of the highest credit standing.

"The term "Closing Date" with respect to the Group of the Equipment shall mean June 28, 1973."

3. Except as amended hereby, the Manufacturing Agreement shall remain unaltered and in full force and effect.

4. The Lessee will promptly cause this Amendment Agreement to be filed and recorded with the Interstate Commerce Commission in accordance with Section 20c of the Interstate Commerce Act.
